PARADE RULES PLEASE READ CAREFULLY!

ALL PARTICIPANTS WILL HAVE TO ATTEND A MANDATORY SAFETY MEETING!

1. **ALL** vehicles, motorcycles, floats, ext. **MUST BE** decorated and have Christmas Lights.
2. Maximum of 2 vehicles per entry.
3. Commercial case by case situations unless pulling a float.
4. **NO** throwing of handouts (flyers), **NO** throwing candy
(Only walking participants can hand out candy)
5. **NO** stopping the parade route. **ALL** routes and performances must be done while moving with the flow of the parade. **AGAIN NO STOPPING!! THIS IS STRICTLY ENFORCED!!**
6. **NO LIVE SANTA(S) OR MRS. SANTA(S).**
7. **ALL** entries must have large signs or banners to identify themselves.
8. The parade organizers reserve the right to limit or refuse an entry.
9. **ALL** vehicles in the parade are to be operated by a driver at least 18 years of age and have a valid driver's license and proper insurance for the vehicles. Each vehicle must have a passenger accompany the driver.
10. No unsafe, careless or reckless driving or behavior by parade participants. Demonstrations of maneuverability, horsepower, speed, agility, etc. will not be permitted by any entry in the parade, to include, go-carts, modified trucks, motorcycles, race cars, lawn mowers, etc.
11. No children under 10 years of age shall walk next to or in the vicinity of an entry. Individuals over the age of ten shall stand clear of or behind all floats, vehicles, trailers and other motorized entries or large animals.
12. No "Outrigger" or protruding or open wheels will be permitted on any trailers, floats or other conveyances that have participants riding on them. They must be capped and or covered. The use of entries with protruding wheels or other appendages that might snare a parade participant or spectator is prohibited.
13. Feet and limbs must be kept inside of the parade entry.
14. Each float must have a safety monitor. The designated safety monitor and any other person your organization chooses to designate must attend the Mandatory Safety Meeting in order to participate.
15. Each participant is required to sign a liability disclaimer. These disclaimers will be sent out in your parade packet and will be available at the Safety Meeting. **ALL DISCLAIMERS MUST BE TURNED IN BY WEDNESDAY NOVEMBER 30TH!**
